- 7.3 The COL has ratified the decision of the **Chief Commissioner** to appoint Gp Comr Michael Hodge, as Acting Federal Administration Commissioner.
 - 7.3.1 This appointment confers upon its incumbent a seat on the COL.
 - 7.3.2 There is no term of office for this appointment.
- 7.4 The COL has ratified the decision of the **Chief Commissioner** to promote Gp Comr Martin Ball to Lt Comr and to appoint him as Group Executive Commissioner of South Australia Group, effective 8 December 2018.

13.2.1 AAL Units must not attempt to enter such agreements without referral, through the chain of command, to the Chief Commissioner.

- 13.3 The above ABN cannot be used for any other types of agreements, by any AAL Unit, without proper authorisation.
 - 13.3.1 Approval can be sought to use this ABN, through the chain of command, to the Chief Commissioner.

13.3.2 Approval will not be unreasonably withheld.

13.4 AAL Units are not able to use any other ABN for any of the above purposes.
