### 6.0 AAL Manual Amendments

6.1 The Australian Air League Manual located on *AAL Wiki* at <a href="http://manual.airleague.com.au">http://manual.airleague.com.au</a> (see F/SO/02/15 for access details) has been amended as follows:

### 6.2 Section 10 Ceremonial Drill, Catafalque Ceremonies Paragraph 33.2.4

- 6.2.1 Section 10, *Paragraph 33.2.4* has been amended to remove the words "sticks, poles,". This paragraph now reads:
- 6.2.2 "When offering or replying to requests to supply a Catafalque Party, it must be made clear that no AAL members are permitted to carry or use weapons in any form either active or de-activated, or items used or intended to be used to simulate weapons. This includes but is not limited to firearms, replica firearms, swords, battens, etc."

# 6.3 **Section 18 Uniforms, Authorised Name Badges**

- 6.3.1 See 7.0 below for details regarding the approval of badges for Officers, Supernumeraries and Associate Members.
- 6.3.2 To accommodate the wearing of name badges with the AAL Uniform, the manual has been amended in Section 18 Uniforms, where a new paragraph, entitled: "50. Authorised Name Badges" has been added covering: design; approved content; and authorised usage.
- 6.3.3 Section 18 Uniforms, "50. Appendix 1 (Uniforms)" has been renumbered as "51. Appendix 1 (Uniforms)".

## 6.4 Section 18 Uniforms, Clarification on Wearing of Slacks by Female Members.

- 6.4.1 As a consequence of the decision by the Council of the League regarding wearing of slacks by female members (see 8.0 below), amendments have been made in a number of areas of Section 18:
- 6.4.2 *Para 15.Uniform Items General and Introduction*: New paragraph 5.4 stating that female members may wear slacks (as described) in lieu of the female skirt, at any time.
- 6.4.3 *Para 33.Trousers/Slacks Cadet/Senior*: Amendment to existing *paragraph 33.1* regarding specifications for Trousers worn by Male Members.
- 6.4.4 *Para 33. Trousers/Slacks Cadet/Senior*. Amendment to existing *paragraph 33.2* regarding specifications for Slacks worn by Female Members.
- 6.4.5 Para 36.Slacks Female Junior: Amendment to existing paragraph 36.1 regarding specifications for Slacks worn by Female Junior Members.

# 7.0 <u>Authorised Name Badges for Officers, Supernumeraries and Associate Members</u>

- 7.1 The Council of the League has approved the wearing of name badges for use on Officer and Supernumerary uniforms.
- 7.2 Associate members may also wear a name badge.
- 7.3 Only name badges authorised and made available for purchase through Federal are able to be worn.
- 7.4 For full details on design and on how to order, refer to Federal Administration Instruction No 79/2016 dated 29 February 2016.
- 7.5 The following key points should be noted:
- 7.5.1 For officers in uniform, the badge must be worn above the right breast pocket and centrally above any medal ribbons or life membership award;
- 7.5.2 Name badges can be worn at any time except for ceremonial or review parades, or any other occasion when their wearing is specifically banned;
- 7.5.3 NCOs and cadets are not authorised to wear name badges.
- 7.5.4 The wearing of authorised name badges is optional.

### 8.0 Wearing of Slacks by Female Members

8.1 The Council of the League has approved a change which permits female members of the League (both officers and cadets) to wear authorised Australian Air League slacks at any time in lieu of skirts.

## 9.0 Squadron/Wing Financial Returns

- 9.1 Units with a balance date of 31<sup>st</sup> March 2016 are reminded that their end of year financial returns (two copies) are required to be lodged with their relevant Group Headquarters by no later than 31<sup>st</sup> May 2016.
- 9.2 The returns to be included are:
- 9.2.1 Cash Receipts for all accounts from April 2015 to March 2016 inclusive;
- 9.2.2 Cash Payments for all accounts from April 2015 to March 2016 inclusive;
- 9.2.3 Trial Balance for all accounts for the financial period;
- 9.2.4 Income and Expenditure Account for the period ended 31st March 2016;
- 9.2.5 Stock List as at 31<sup>st</sup> March 2016 valued at cost;
- 9.2.6 Listing of all assets at the written down value and replacement value;
- 9.2.7 Debtors Listing as at 31<sup>st</sup> March 2016;
- 9.2.8 Creditors Listing as at 31<sup>st</sup> March 2016;
- 9.2.9 Balance Sheet as at 31st March 2016.
- 9.2.10 Copy of Bank Statement as at 31st March 2016 for all bank accounts
- 9.3 The above submission of documents may be in one of two forms:
- 9.3.1 By 'hard copy' (all items); OR
- 9.3.2 By submission of the completed electronic 43/44 package plus a scanned copy of relevant Bank Statement(s).
- 9.4 All Groups are required to forward a copy of each Unit's end of year financial returns to the Chief Commissioner to be received no later than 30<sup>th</sup> June 2016.
